Mission, Purpose, and Educational Objectives of the Graduate School of Medicine, Hyogo Medical University

Mission

The Graduate School of Medicine, Hyogo Medical University carries forward the founding principles of "Service to the Welfare of Society," "Profound Love for Humanity," and "Broad Scientific Understanding of Humanity." From an advanced scientific perspective, we explore the truth about health and disease and contribute to societal welfare through the outcomes of our research.

Purpose

The Graduate School of Medicine aims to cultivate advanced research skills by equipping students with specialized knowledge and techniques in medicine, fostering high ethical standards in medical care and research, and developing the ability to design and carry out innovative research. Through disseminating research findings globally and contributing them to society, we nurture individuals who can advance medicine and medical care.

Educational Objectives

The Graduate School of Medicine aims to cultivate individuals with the following abilities:

- 1. Develop advanced research and development skills, as well as specialized knowledge and techniques related to medicine.
- 2. Foster compassionate humanity, ethical awareness, broad collaboration with society, the qualities of a global citizen, and the ability to engage in lifelong advanced learning through educational and research activities.

[Admissions Policy]

The Graduate School of Medicine, Hyogo Medical University provides an environment for learning and advancing medical theories and their applications, based on the founding spirit of "service to the welfare of society," "profound love for humanity," and "broad scientific understanding of humanity." Specifically, by cultivating advanced research skills, a wealth of knowledge as a foundation, and a profound spirit of human compassion, the institution aims to develop creative and independent researchers, healthcare professionals with advanced expertise and skills, and educators who contribute to the inheritance and advancement of these values. Additionally, the school strives to give back the results of its research activities to society at large, thereby contributing to the progress of medicine and healthcare.

To achieve these goals, the school seeks students with the following qualities.

- 1. Individuals with a spirit of profound human compassion and a strong aspiration to contribute to society through research activities.

- 4. Individuals with a scientific inquisitiveness and the drive to produce innovative medical research outcomes.
- 5. Individuals with the desire to acquire deep and broad expertise in advanced medical knowledge.
- 6. Individuals aspiring to become altruistic healthcare professionals, researchers, or educators capable of selflessly mentoring others.
- 7. Individuals eager to cultivate a wealth of knowledge and high ethical standards.
- 8. Individuals aiming to develop, master, and disseminate cutting-edge medical technologies.
- 9. Individuals with ambitions to thrive globally through international research activities.

[Selection Process]

Candidates are evaluated on their ability to excel in research and study across a wide range of medical fields. Basic reading and comprehension skills in medical English are assessed through an English proficiency test. Additionally, interviews are conducted to gauge fundamental knowledge of the chosen research field, clarity of thought, enthusiasm for learning, logical reasoning, and the ability to apply knowledge. These evaluations are used to select qualified applicants for admission.

★ Day and Night Course Systems

To accommodate working professionals, the "Special Provisions for Educational Methods under Article 14 of the Graduate School Establishment Standards" will be applied. In cases where special educational needs are recognized, education is provided through methods such as evening classes or research guidance during specific times or periods, allowing students to continue their employment without interruption. Evening classes will be held during the 6th period (18:00–19:30) and the 7th period (19:40–21:10).

Working professionals are defined as individuals employed at hospitals, educational or research institutions, companies, or similar organizations who retain their employment status after enrollment.

★ Tuition Fee Waiver System

1. Ful Exemption

In accordance with the Internal Regulations for Tuition Reduction and Exemption of the Graduate School of Medicine, Hyogo Medical University, tuition fees for both the regular and extended enrollment periods may be exempted for students who are not in regular employment and who meet one of the following conditions, provided they primarily attend classes and receive research supervision during daytime hours.

- 1) Students whose supervising professor belongs to <u>Departments of Basic Sciences</u>, the <u>Institute for Advanced Medical Sciences</u>, or <u>Departments of Liberal Arts</u> (see attached table)
- 2) International special students who hold the "Student" status of residence as defined in Appended Table I of the Immigration Control and Refugee Recognition Act

2. Reduction

In accordance with the Internal Regulations for Tuition Reduction and Exemption of the Graduate School of Medicine, Hyogo Medical University, tuition fees and educational enhancement fees will be reduced for students who can prove that their monthly base salary (including part-time income) is 250,000 yen or less, regardless of whether they have a full-time job.

*In both cases, annual applications must be submitted, and approval from the Dean of the Graduate School of Medicine is required.

Eligibility for Application

- 1. Individuals who have graduated or are expected to graduate by March 2026 from a course that includes studies in medicine, dentistry, or a veterinary or pharmaceutical program lasting six years.
- 2. Individuals who have completed a <u>18-year educational program</u> abroad, (with the final stage being in medicine, dentistry, veterinary science, or pharmacy).
- *In some countries, the total education duration may not be 18 years; such cases will require a separate qualification review.
- 3. Those Designated by the Minister of Education, Culture, Sports, Science, and Technology [The following individuals are considered to be designated by the Minister of Education, Culture, Sports, Science, and Technology]:
 - ① Those who completed studies in medicine or dentistry under the former university regulations (Imperial Ordinance No. 388, 1918) and graduated from medical or dental faculties.
- ② Those who have completed a master's program or are eligible to be awarded a master's degree.

- ③ Those who have been enrolled in a doctoral program that does not differentiate between a two-year and three-year system for more than two years, have earned at least 30 credits, and have received the required research guidance (including those who meet the criteria outlined in Article 6, Paragraph 1 of the previous Degree Regulations, amended by Ministry of Education Ordinance No. 29 of 1974). Applicants are further required to be recognized as having academic abilities equivalent to or higher than graduates of university courses in medicine, dentistry, or veterinary medicine, based on education at a graduate school or specialized program.
- 4 Those who have graduated from a university (excluding courses in medicine, dentistry, veterinary medicine with a six-year curriculum, or pharmacy with a six-year curriculum) or completed 16 years of formal education abroad. Additionally, they must have engaged in research at a university, research institute, or similar institution for at least two years. Applicants are further required to demonstrate, through the outcomes of their research or equivalent achievements, academic abilities recognized by the Graduate School of Medicine as being equal to or exceeding those of graduates of university programs in medicine, dentistry, veterinary medicine with a six-year curriculum, or pharmacy with a six-year curriculum.
- Those who are recognized by the Graduate School of Medicine, through an individual admission qualification screening, as having academic abilities equal to or higher than those of graduates from university programs in medicine, dentistry, veterinary medicine with a six-year curriculum, or pharmacy with a six-year curriculum. Additionally, applicants must be at least 24 years old as of April 1, 2026.

Application Eligibility Screening

A. Applicants who fall under the "Eligibility for Application" criteria 3.4 or 3.5, as well as international special students, are required to undergo an application eligibility screening prior to applying. The following documents must be submitted to the Nishinomiya Academic Affairs Division within the specified period. The results of the eligibility screening will be notified to the applicants.

a. Eligibility Screening Document Submission Period

The submission hours are from 9:00 AM to 5:00 PM on weekdays. (Submissions will not be accepted on Saturdays, Sundays, or public holidays.) For postal submissions, the date of the postmark within the submission period will be considered valid.

b. Application Documents

The application must be submitted using the Admission Qualification Review Application Form (Form 1).

- **B.** Applicants for admission as international special students must meet one of the criteria outlined in "Eligibility for Admission" sections 2 or 3, and must have a recommendation from a supervising professor.
- **C.** For applicants who are physicians (or dentists) and whose supervising professor is from a clinical department, it is desirable that the applicant has completed or is expected to complete clinical training as specified by the Medical Practitioners Act (or the Dentists Act).

Applicants with Physical Disabilities or Impairments

Applicants with physical disabilities or impairments who require special accommodations for the entrance exam or academic studies should, in principle, contact the Nishinomiya Academic Affairs Division (Graduate School Section) at least one month prior to each exam (TEL: 0798-45-6163). Additionally, applicants may be asked to submit documentation such as a medical certificate from a specialist to indicate the extent of their disability.

Admission Selection Procedure

Admission will be determined through a comprehensive evaluation of the entrance examination results and the academic transcript from the applicant's previous university.

Interview [In some cases, the interview may be waived if the applicant has already had an interview with the supervising professor.]

- 2. Failure to complete the above procedures by the specified deadline will be considered a forfeiture of intent to enroll, and acceptance will be revoked.
- 3. For those who formally decline admission by the final day of the enrollment procedure period, fees such as tuition and education enhancement fees will be refunded, excluding the admission fee.

Disclosure of Individual Scores for Entrance Examinations (Early/Late Admission) and Foreign Language Tests Without Course Completion

Individual scores for entrance examinations (Early/Late Admission) and foreign language tests without course completion will be disclosed only upon request from the examinee, following the guidelines outlined below.

- 1. Eligible Applicants: those who failed the entrance examination for the FY 2026 and those who failed the foreign language test without course completion.
- 2. Disclosed Information: Foreign language test scores.
- 3. Application Period: April 1, 2026 (Wednesday) to April 3, 2026 (Friday) (postmark valid).
- 4. Disclosure Date: From May 1, 2026 (Friday).
- 5. Application Procedure: Write "Request for Examination Results Disclosure" in red ink on the envelope and send the following documents by mail:

Research Assistant (RA) Program

To further enhance the research support system that contributes to the advancement of academic research, this program recruits a limited number of research assistants from among non-physicians and international special students (excluding those enrolled in evening programs). Selected individuals will engage in auxiliary tasks for research projects conducted by the university and receive a stipend of approximately ¥100,000 per month.

Teaching Assistant (TA) Program

To enhance the quality of university education and cultivate future educators, a limited number of teaching assistants will be recruited from among students who primarily attend classes and receive research supervision during daytime hours. Teaching assistants will perform educational support duties and receive an annual stipend of up to 180,000 yen.

Student Education and Research Accident Insurance (Managed by the Japan Educational Exchanges and Services Foundation)

This insurance provides coverage for accidents or disasters occurring during experiments, practical training, official school events, or extracurricular activities while enrolled in graduate school. Students can join the program by paying a premium of ¥3,370 for four years (as of the FY2025).
